New Business 6.1 Motion *CO-20150420-06*



Whereas election regulation section III-2 states that the judicial board has 48 hours to address appeals

Whereas Keroles Riad's appeal was submitted on Saturday the 4th and as of now, Friday the 10th, a time for the appeal has not been determined despite the fact that 48 hours have already passed including more than 2 business days.

Whereas the regulation clearly outlines a timeline where candidates have 3 days to appeal and the board has 2 days to convene, it is easily predictable that elections timeline must accommodate at least 5 days after the announcement of results for the appeal process. The proximity of Easter holidays to elections was an organizational failure.

Whereas GSA does not even have a complete judicial board in place.

Whereas the candidate has the right to due process and a fair hearing that can NO LONGER be provided as the regulations have already been violated by the board.

BIRT the appeal be automatically accepted and that the CRO's decision of disqualification be overturned.

BIFRT the CRO announces that Keroles Riad has won council's INDI seat by acclaimation.

BIFRT the CRO announces how many votes the candidate received in the senate race and adjust the results accordingly if necessary.

We the Council of Directors of the Graduate Students Association of Concordia University hereby endorse the following statement and resolution.

We believe that a University education should be accessible to all and that all citizens deserve unfettered access to quality well-funded social services regardless of economic class.

We renounce the Couillard Liberal Regime and their short-sighted adherence to neo-liberal policies that favor corporate concerns over social benefits. We acknowledge that recent budget cuts will affect accessibility, placing undue stress upon our members and further deplete the already struggling social services that are the backbone of our communities.

We the Council of Directors of the Graduate Students Association of Concordia University hereby endorse the following statement and resolution. We reject political targeting of student leaders upholding mandates given to them through their memberships.

We deplore Education Minister Francois Blais' admonition to expel "two to three students" per day in an attempt to intimidate students from participating in General Assemblies and popular demonstrations.

We recognize that the violent disposition of the Montreal Police in the face of student democracy will only escalate conflicts.

We applaud the recent Quebec Superior court decision that student associations and assemblies preserve pluralism and ensure student representation in political debates.

In light of the above **BIRT**, the GSA takes a position against the political expulsions of students at UQAM and the sanctioning of students on strike at Concordia, as well as any comparable actions taken against student leaders, professors or staff at any other CEGEP or University.
