WHEREAS the Graduate Students' Association of Concordia University (GSA) believes in freedom of expression for all regardless of their gender, ethnicity, sexual orientation, or religion save those statements that perpetuate false stereotypes or incite hatred;

WHEREAS the prohibition of wearing of religious symbols by employees of the Quebec government would appear to apply to graduate students employed by the university (but not those receiving bursaries), creating a potentially unfair and chaotic situation;

WHEREAS the government of Quebec has not carried out research to support their policy and predict its outcomes;

**BIRT the General Assembly of the GSA opposes the proposed Bill 60 and calls for its withdrawal from consideration;**

**BIFRT the GSA opposes any similar future proposal that does not safeguard the freedom of conscience and religion.**
