## Approval unanimous

- 1. Approval of December 9 meeting minutes
  - a. Altayeb has concerns in regards to minutes, specifically council's decision to issue requests.
  - b. Altayeb states that executives were either honorarium positions or paid positions he believes they are semi-voluntary
  - c. Erik explains that the positions were validated last year as paid positions as the workload far surpasses the norm for a volunteer position. This was based on a 15\$ per hour rate and the executive far surpasses this amount of hours.
  - d. Roddy there is an obvious communication problem
  - e. Mah states that executive are employees council approves the amount annually
  - f. Altayeb I would do this job voluntarily, and at the executive meeting nobody mentioned any delays to me or concerns. This makes me feel that there is an injustice and I am not sure where I stand with everybody. This is not fair.
  - g. Svetla We require executive meeting minutes and there are delays in receiving council meeting minutes. It makes it difficult for us to know what is going on and then decisions are made in executive meetings that we are unaware of. We also do not receive reports regularly so in the end we have no idea what is going on.
  - h. Erik We need to establish better communications among executives.
  - i. Mah I am sending e-mails and some of the executives do not respond.
  - j. Manu Can we doodle? This would make scheduling much easier...
  - k. Mah It is too difficult to know whether we have quorum...and nobody responds to emails.
  - I. Faisal I concerned about minutes, I have no problems with VP Finance
  - m. Erik All of my financial concerns have been taken care of I spoke with Altayeb this week.
  - n. Sussan do you confront him as directly as you are now complaining about him (Manu)

- o. Faisal major concern is whether Manu needs help with advocacy center
- p. Erik he knows that there are problems
- g. Svetla Can we trust him to do this?
- r. Faisal he has been doing stuff, proposal for CCSL and other projects were completed we need all minutes on time.
- s. Mah my major concerns are minutes, auditor, and budget committee meeting
- t. Altayeb We can have budget committee meeting, and I will contact the auditor.
- u. Peipei We have one council meeting per month and if executive member does not show up we have no way of speaking to them to find out what they are doing.
- v. Nadia I propose we accept minutes of December 9, 2009 striking portions referring to Altayeb's performance, and making other necessary corrections as mandated by council. Roddy will provide updated minutes by January 4, 2010. Seconded by Peipei

- ee. Altayeb Finance committee of Senate ASEQ is paid and CFS payments are going to be released by year-end.

- gg. Mah We asked them to come and present to us, they missed the meeting and the executive committee approved 500\$ pending payment once we see proof of sponsorship.

- jj. Sussan moves that Mah extend an invitation to the TRAC executive to present the new union contract to our council. Faisal seconds
