New Business

6.1 Motion regarding the Israeli offensive in Gaza (Jon Summers)

Whereas the State of Israel has been widely recognized by the global community as a colonialist, apartheid state that contravenes international law in its treatment of the Palestinian people;

Whereas the State of Israel has, since July 8, been launching an offensive against the people of the Gaza Strip that has killed over 700 and injured more than 4,500, many of whom are children and other civilians, in addition to destroying homes, schools, hospitals, and key infrastructure;

Whereas Prime Minister Stephen Harper of the Conservative Party of Canada has been unrelenting in his support of the State of Israel, as have Liberal leader Justin Trudeau and NDP leader Thomas Mulcair;

Whereas the GSA has an existing mandate from the General Assembly to support the global Boycott, Divestment, and Sanctions (BDS) movement against the State of Israel;

BIRT the GSA reassert its support for the BDS campaign against the State of Israel;

BIFRT the GSA denounce in the strongest possible terms the colonialism and the segregationism of the



State of Israel as well as its ongoing assault on the Gaza Strip;

BIFRT the GSA also denounce those political leaders who support the actions of the State of Israel;

BIFRT the VP External and the Campaigns Committee work with other groups to organize events and mobilize GSA members on this issue.

6.2 GSA T-shirts

Whereas the GSA requires greater visibility among the student population, especially considering its upcoming accreditation drive;

BIRT the VP Internal have GSA t-shirts produced for councillors, executive, and staff by September 2, 2014;

BIFRT these t-shirts be made from organic cotton in sweatshop-free conditions.

Hi everyone,

There is not a lot new to report on from my end this past month since I took my vacation in July. Now that I'm back, I've been following up on requests that we've been making for orientation. One thing that I've been working on is finding a better location for the first fall general assembly, as requested at the last council meeting. I contacted Hospitality Concordia and they have put us on a waiting list for H-439 for the same time as our other booking – Thursday October 2nd from 6-9. If there is a class that needs to happen in this room, we won't have access, but if not, we will have priority. Another option is I have submitted a request for the CSU 7th floor lounge space for 2 days earlier, the evening of Tuesday, September 30th. Action Plan

The GSA executive's Visioning and Planning goals for 2014-2015 were set to be approved and updated by the council,

1) Increasing volunteer opportunity:

Besides, advertisement of GSA shall be placed at different places in Concordia campus, and a volunteer appreciation process will be developed. 2) Student Engagement:

Increase communication with departmental associations and the department or Faculty administrations to promote GSA initiatives. Organizing social events for students with different interests, and serve students from different communities. Scheduling class visits to increase awareness regarding GSA services.

3) Increasing Advocacy Support

Roddy shall make a report outlining overall advocacy services available at the GSA and his visions regarding additional advocacy support services he feels necessary for GSA members.

5) Marketable Skill Building

- -Bring concrete improvements to the passage of Quebec's university students throughout their studies by working on issues capable of improving the quality of teaching, supervision, and



support provided to them.

- -Provide the most complete information possible to Quebec's university student associations and their members about the dossiers treated and the means to improve the living conditions of Quebec's students.
- -Favor unity within the Quebec student movement.
