Natheer asked if there is fear of problems with international students and being detained. Roddy responded that no immigration problems incurred with the GSA. Mohammed Sabr asked what exactly is the effect of the protest both in direct relation with the GSA and in general. Roddy responded by naming several big named individual who now know of the GSA.

## 4.0 Water bottle free Concordia.

---

There is a campaign to remove bottled water from campus. The goal is to remove bottle water from the beverage contract, which is due to be rewritten in the near future. On top of removing water bottles, there are 4 other objectives to achieve in the new beverage contract.

1. Health conscious and environmentally friendly products
2. Non-Exclusive contracts, in order to involve local companies.
3. No bottled water.
4. Negotiations of the beverage contract are clear, transparent, and democratic.

What is asked for by GSA is formal letter of support for these objectives. The objectives will be attached in the appendix.

Orientation costs are changed to match change in COI funding change. Orientation spending must be at least twice the COI funding amount.

Council will review the budget item by item and changes are suggested. Items are discussed. Conference subsidies are increased to 7000\$. The TA centre is removed. Career placement workshop is removed. Campaigning and legal expenses are merged together to be 7000\$.
