GSA President's address to the January 29, 2016 General Assembly

Successful winter 2016 Orientation

This semester we had a successful winter 2016 orientation. We had 11 orientation events over a one week duration. We had a good attendance for the events and thank all students that attended. Renovation of the GSA lounge

GSA Services

This year we have been working towards improving the services that we provide and introducing new ones. We reviewed and improved our French and English language classes using the feedback we received. We are working towards maximizing the utilization of our classrooms.

We have hosted several events from June 2015 to date and will be hosting so many other exciting events during the year. We will be happy to welcome GSA members to our student life committee.

GSA 2015-2016 Projects

This year we are working towards establishing an advocacy center in the GSA house. The center will provide students with resources and information to help them make informed decisions. The center will also provide general advising and help in defending the rights of students. The center was set up in the fall 2015 semester, but requires the approval of the council for the new staff positions.

We will be reintroducing subsidized printing and copying services this semester. The low priced prints will help reduce the printing costs for graduate students.

We have included funding for clubs in our budget this year. We will be encouraging graduate students to form clubs during the course of the year.

Anti-Austerity

We will be hoping to consider and pass a motion against Austerity today. The GSA will work with other groups on campus to reject austerity and advocate for an increased funding for education. I strongly encourage all graduate students to support this campaign.

This year we will ensure that we are transparent and accountable to all members. We will be appointing an auditor who will conduct an audit for the 2015-16 financial year. 2.6 Financial Statement (20 mins)

3.1 Austerity (30 mins or more)

Whereas the Quebec governments has implemented repeatedly austerity measures over the past years;

Whereas Quebec's universities have lost about \$400 million in provincial grants, representing a drop of nearly 15% of their operating budget;

Whereas Concordia University has been forced to absorb \$36.6 million in cuts since the 2012-13 academic year;

Whereas as the result of the above, Concordia University is running an \$8.2 million deficit, has left an uncommunicated number of positions vacant or closed them altogether, and has since implemented a Voluntary Departure Program with 90 voluntary departures, resulting in 65 positions being cut;

Whereas as the result of the above, Concordia University has implemented an undisclosed reduction in courses selection, has increased the class size, and has reduced faculty resources for students;

Whereas student associations and unions across Quebec representing workers from the health, the education, and the public sectors at large, have enforced and declared strike actions for the fall 2015,

Whereas student associations are holding strike general assemblies throughout Quebec;

Whereas the Graduate Students Association (GSA) recognizes the need for transparent and open discussions around austerity measures and budget cuts, alongside standing in solidarity with faculty, workers, and other student associations who suffer austerity measures and budget cuts within the education sector.

Whereas the GSA acknowledges the right to education and the importance in taking steps including but not limited to strike mandates, open discussion, mediation and solidarity to resist budget cuts to their education.

Be It Resolved That the GSA denounce the prevailing government discourse of austerity and “budgetary compressions,” and advocate for more just and sustainable economic solutions (such as progressive taxation, addressing tax evasion and corruption, and making corporations and the wealthy pay their fair share)

Be It Further Resolved That the GSA support the group Solidarity 2015 Concordia (including TRAC) and other anti-austerity initiatives at Concordia and elsewhere, with the aim of halting government budget cuts to public services, through an escalation of tactics over the coming months while respecting the community’s rights and safety

BIFRT the GSA campaigns committee and campaigns budget be charged with event planning, mobilization, education, the production of materials and other activities associated with its commitment to the anti-austerity movement.
