1.5 Motion against online or electronic voting during the GSA 2017 elections

Motion CO-20170407-xx (tabled)

Whereas online voting has rejected by several associations and governments. (some after pilot study)

Whereas the GSA council did not do a pilot study or properly access the disadvantages of online voting, considering the GSA specifically.

Whereas fears about privacy, security, voter fraud and malware were not addressed.

Whereas concerns regarding the secrecy and integrity of the ballot was not addressed.

Whereas serious concerns about coercion of voters was not addressed and some students may be vulnerable.

Move 'the latter of which shall consist of the one executive member Executive Committee members, and at least three (3) members of Council representing separate three out of five four faculties, and one staff member. The roles and responsibilities of the General Assembly Committee are:

To draft an agenda for the General Assembly,

To assist the GSA executives to mobilize members to attend the General Assembly, and To manage logistical tasks related to the running of the General assembly' from Article XIX Section 3, 3.1 to Article XXI Section H in the updated bylaws.

Remove Section 5, 5.3 'A notice of meeting placed in the student newspapers.' From Article XIX.

Remove 'in good standing' from Article XIX Section 7.

Change Article XIX Section 10 to 'At least one (1) General Assembly per semester – excluding summer – shall be called (One GA in September, and one GA in January)'.

Add 'A General Assembly by a majority vote.' As section 1, 1.4 in Article XVII in the updated bylaws.

Remove Section 5 from Article XX in the current bylaws.

Motion 35

Remove 'Subject to the General By-Laws or a General Assembly veto, referenda resolutions shall be binding on the Association.' From Article XX Section 8 in the current bylaws.

Change Article XXI Section 3 to 'Any Motion to amend the By-Laws must be adopted by a two-third (2/3) majority of the members voting at the Assembly. Any amendment to the By-Laws shall take effect once adopted by the General Assembly of members.'.

Change the composition of Hiring Committee to:

'The Hiring Committee shall be composed of:

- a. Two (2) relevant executive members, to be chosen by the executive committee.
- b. Three (3) members of Council from separate faculties.
- c. The quorum shall consist of three (3) members.
- d. The hiring committee shall be a closed committee, and all the information discussed in its meetings is kept confidential from the public.'

'The Budget Committee shall be composed of:

- The President who will be chair.
- The Vice-President Internal.
- The Vice-President External.
- One member at large as a non-voting member
- At least four (4) current council directors representing separate faculties and appointed by Council.'
