- 4. Fee Levy Dean of Students Presentation
 - Fee was implemented years ago to begin a process to engage the GSA and increase the Student Services dues. This is a fee of \$10.26 that every Grad student pays for a list of various services.
 - The fee for Grad students hasn't increased in 10 years.
 - Undergrad students approved an increase to this fee last year.
 - Pays for Student Center and Student Services Office.
 - Sadath: Asks Andrew, Dean of Students, if the increase in amount will go to the Students Success Center and its associated organizations.
 Andrew: Dean of Students is one of many different student services. Funds will go to health and psychological services, Dean of Students, and many other services.
 - Wade: As a First Nations Student, he sees the Indigenous perspective reflected in the policy. Asks what a fee levy would do for a wider range of international students at the university.
 - Andrew: These student services do not target Black or Indigenous students for specific support, instead focuses their support across the entire body of Grad students. Policy is usually made by groups that aren't directly connected to the Dean of Students, but those policies will continue to help them do their work.
 - Wade: Indigenous students had a representative from Indigenous Directions, so
 Wade felt represented. But worries that the rest of the students at Concordia might not be properly represented and had their voices heard.

12. New business

- a. Volunteers for Halloween
 - Asking for volunteers for the Halloween party on November 9th.
- b. NDA signatures all the directors
 - Asking all directors to sign the NDA and send it back virtually.
 - Will be emailing the directors with the finalized NDA.
- c. Sustainability investment advisory committee
 - Committee investing in sustainability items at the university. Wanted representation from Grad students. If anyone is interested, we'll be meeting with them on November 6th. GSA Executives can take your name and give it to this committee so you can be a part of the decision making.
- d. Tuition hike issue
 - By Fall 2024, the Grad students will have to pay 30% more than they are right now and Undergrad students will have to pay 50% more than they are right now.
 - Meeting with many colleges in Montreal with two proposals
 - Want to draft an open letter to send to Government of Quebec.
 - Strikes are being organized for Oct. 30th. Plan to Walk Out and meet at Dorchester Square at 1PM – this Walk Out is from McGill and Concordia.
 - Asked Concordia about their action plan. Dean of Students is on the side of students to try and prevent the tuition hike.
 - Arnav: Had meeting with Provost, this is a really serious situation. If this
 plays out, some Concordia departments could be closed down because
 they're made almost entirely of International students. Importance to
 keep people informed about this.
 - Carlos: Asks Arnav to share demographic information with directors so they can help their students more.
 - Arnav: Demographic info request has been approved, but not fully, not all information will be disclosed.
- e. Summer advocacy report
 - If a Graduate student is accused of Academic Misconduct, they can come to the GSA and discuss the issue and receive support through advocacy for the student.
- f. Funding for the conference
 - Having trouble with funding, thinking \$8,000 would be enough.
 - Students did not understand how much money they would be receiving,

- GSA has to rework the budget to make sure the funding will work.
- Going to have a meeting with the Policy Committee and get funding approved with upcoming Council meeting.
- Carlos: School of Graduate Studies gives conference funding based on travel distance. Maybe GSA can do something similar.
- Arbaaz: The policy will have to be arranged in a way that could support all Graduate students equally.

g. Fee levy groups

- GSA has 15 fee levy groups currently.
- Question of why we have to pay a fee from Grad students to the fee levy groups.
- These groups are meant to be fruitful to the Grad students. To spread awareness, we are going to have two fee levy groups attending GSA meetings every month in order to explain to GSA why they should be funded.
- Bi-election will be held before the end of the semester.

14. Legal

- Patrice presenting as part of the GSA's Legal Council.
- Came to Council in May during the previous mandate.
- When it came time to implement Collective Agreement, the document was very poorly written and incoherent. Negotiating table corrected lots of this, but the salary scales was something that was very confusing.
- Big disagreement on salary scale was where the growth rate happened.
- New Salary Scale Salaries will be increased by the higher of the following on June 1st of every year:
 - 0 2023-2024: 4%
 - o 2024-2025: 5% or CPI+2%
 - o 2025-2026: 3.5% or CPI+1%
 - o 2026-2027: 2% or CPI-0.5%
 - o 2027-2028: 2% or CPI-1%
 - o 2028-2029: 2% or CPI-1%
- This change has to be agreed on by GSA council and union members.
- Creation of a Labour Relations Committee (CRT) most unions have this but the GSA don't yet.
 - O Demand was left on the side because GSA was able to win 8/9 demands.
 - o Problems of hiring will be handled through Labor Relations Committee
- Things to approve now New Salary Scale and Creation of Labour Relations Committee
- Nilesh: Would like for each of council members to have more time to go through the document thoroughly before voting on it.
- Arbaaz: Patrice has thoroughly gone through the document itself. Continues to explain the context and specifics of the document, the New Salary Scale, and the Creation of Labour Relations Committee.
